On 6/17/2024 I, Sergeant Shawn O'Brien was working the 0700-1700 hour shift for the Amesbury Police Department. At approximately 1233 hours I was dispatched to 11 Willowdale Court for a report of a two year old that was bit by his dog.

Upon arrival Amesbury Fire was on scene. The two year old was identified as _____ who was being walked into the Ambulance by his father, Eric Anderson. _____ had been bit in the side/back of his neck by the family dog (Jasper). There was a 1 inch laceration to _____ neck that Eric was applying pressure to. _____ was seat belted in the Ambulance and transported to the Ana Jaques hospital. EMS stated that _____ was most likely going to need stitches.

I stayed on scene and spoke with Eric. Eric explained that _____ went to pet Jasper. Then Jasper just bit _____ on the back of the neck.

I asked Eric if this was the first time the dog had attacked anyone/anything. Eric said that this dog has attacked the other family dog a few times. Eric said that they planned on rehoming the dog in the future.
