Subject: National Grid and Verizon Joint Pole Pet. – Work Request #30922909 **Poplar Street** (ext.)
Proposed Pole location Petition and Sketch received at the Office of the City Clerk April 29, 2024

The Amesbury DPW has reviewed the proposed joint pole location and anchor requested by National Grid and Verizon in the field. The Petition Plan WR (work request) #30922909 is dated March 9, 2024.

The DPW has no significant concerns with the location of this pole. The DPW would request that National Grid and Verizon confirm that the proposed location does not conflict with other utilities within the edge of the City right of way prior to installation. Care should also be taken to ensure the proposed pole anchor is also installed in the right of way. National Grid did stake the location prior to requesting a hearing. Dig Safe requests should be made by National Grid prior to any work at this location.

Care should be taken to ensure the pole is installed within the right of way, but where possible three to four feet from the edge of pavement, away from the edge of the road to leave space for snow storage. Installation of poles in the paved road or walk should be avoided where possible.

Prior to installation or relocation of any utility pole, the City of Amesbury Department of Public Works, and the City Water and Sewer Departments shall be informed of the proposed activities.

PETITION FOR JOINT OR IDENTICAL POLE LOCATIONS

To The City Council

Massachusetts Electric Company d/b/a NATIONAL GRID and Verizon New England, Inc requests permission to locate poles, wires, and fixtures, including the necessary sustaining and protecting fixtures, along and across the following public way:

Poplar Street Ext. - National Grid to install 1 JO pole on Poplar Street Ext. beginning at a point approximately 75 feet Northerly from existing pole 7, Poplar Street Ext. location. National Grid proposes to install new pole 8 with anchor approximately 75' across the street from existing pole 7 in order to provide electric service to a new home located at 39 Poplar Street Ext., Amesbury, MA.

Location approximately as shown on plan attached.

Wherefore it prays that after due notice and hearing as provided by law, it be granted a location for and permission to erect and maintain poles and wires, together with such sustaining and protecting fixtures as it may find necessary, said poles to be erected substantially in accordance with the plan filed herewith marked – Poplar Street Ext. - Amesbury, Massachusetts.



ORDER FOR JOINT OR IDENTICAL POLE LOCATIONS

To the City Council of - Amesbury, Massachusetts

Notice having been given and public hearing held, as provided by law,
IT IS HEREBY ORDERED: that Massachusetts Electric Company d/b/a NATIONAL GRID and VERIZON NEW ENGLAND INC. (formerly known as NEW ENGLAND TELEPHONE AND TELEGRAPH COMPANY) be and they are hereby granted joint or identical locations for and permission to erect and maintain poles and wires to be placed thereon, together with such sustaining and protecting fixtures as said Companies may deem necessary, in the public way or ways hereinafter referred to, as requested in petition of said Companies dated the 19th day of March, 2024.

All construction under this order shall be in accordance with the following conditions:

Poles shall be of sound timber, and reasonable straight, and shall be set substantially at the points indicated upon the plan marked – Poplar Street Ext. - Amesbury, Massachusetts.

There may be attached to said poles by Massachusetts Electric Company d/b/a NATIONAL GRID and Verizon New England Inc. such wires, cables, and fixtures as needed in their business and all of said wires and cables shall be placed at a height of not less than twenty (20) feet from the ground.
