Subject: National Grid and Verizon Joint Pole Pet. – Work Request #30630084 Market Street
Proposed Pole location Petition and Sketch received at the Office of the City Clerk May 8, 2024

The Amesbury DPW has reviewed the proposed joint pole location requested by National Grid and Verizon in Market Street, opposite 121 Market Street. It is designated pole 23-50. The Petition Plan WR (work request) #30630084, the submitted plan is dated January 19, 2024.

The DPW has no significant concerns with the location of this pole. DPW would request that National Grid and Verizon confirm that the proposed location does not conflict with other utilities within the edge of the City right of way prior to installation. National Grid did stake the location in advance of requesting a hearing. Dig Safe requests should be made by National Grid in advance of any work at this location.

Care should be taken to ensure the pole is installed within the right of way, but where possible three to four feet from the edge of pavement, away from the edge of the road to leave space for snow storage. Installation of poles in the paved road or walk should be avoided where possible.

Prior to installation or relocation of any utility pole the City of Amesbury Department of Public Works, and the City Water and Sewer Departments shall be informed of the proposed activities.

ORDER FOR JOINT OR IDENTICAL POLE LOCATIONS

To the City Council of - Amesbury, Massachusetts

Notice having been given and public hearing held, as provided by law,
IT IS HEREBY ORDERED: that Massachusetts Electric Company d/b/a NATIONAL GRID and VERIZON NEW ENGLAND INC. (formerly known as NEW ENGLAND TELEPHONE AND TELEGRAPH COMPANY) be and they are hereby granted joint or identical locations for and permission to erect and maintain poles and wires to be placed thereon, together with such sustaining and protecting fixtures as said Companies may deem necessary, in the public way or ways hereinafter referred to, as requested in petition of said Companies dated the 22nd day of January, 2024.

All construction under this order shall be in accordance with the following conditions:

Poles shall be of sound timber, and reasonable straight, and shall be set substantially at the points indicated upon the plan marked – Market Street - Amesbury, Massachusetts.

Filed with this order:

There may be attached to said poles by Massachusetts Electric Company d/b/a NATIONAL GRID and Verizon New England Inc. such wires, cables, and fixtures as needed in their business and all of said wires and cables shall be placed at a height of not less than twenty (20) feet from the ground.

The following are the public ways or part of ways along which the poles above referred to may be erected, and the number of poles which may be erected thereon under this order:

Market Street - National Grid to install 1 JO pole on Market Street beginning at a point approximately 120 feet Northwest of the centerline of the intersection of Market Street and Auzman Street. National Grid to install one pole (P23-50) on Market Street to the West side of the road. Nearest address is 118 Market Street, Amesbury, Ma. The new pole location is needed due to the new step-down transformers being installed, Amesbury, Ma.

Also, for permission to lay and maintain underground laterals, cables, and wires in the above or intersecting public ways for the purpose of making connections with such poles and buildings as each of said petitioners may desire for distributing purposes.

PETITION FOR JOINT OR IDENTICAL POLE LOCATIONS

North Andover, Massachusetts

To The City Council
Of Amesbury, Massachusetts

Massachusetts Electric Company d/b/a NATIONAL GRID and Verizon New England, Inc requests permission to locate poles, wires, and fixtures, including the necessary sustaining and protecting fixtures, along and across the following public way:

Market Street - National Grid to install 1 JO pole on Market Street beginning at a point approximately 210 feet Northwest of the centerline of the intersection of Market Street and Auzman Street. National Grid to install one pole (P23-50) on Market Street to the West side of the road. Nearest address is 120 Market Street, Amesbury, Ma. The new pole location is needed due to the new step-down transformers being installed, Amesbury, Ma.

Location approximately as shown on plan attached.

Wherefore it prays that after due notice and hearing as provided by law, it be granted a location for and permission to erect and maintain poles and wires, together with such sustaining and protecting fixtures as it may find necessary, said poles to be erected substantially in accordance with the plan filed herewith marked – Market Street - Amesbury, Massachusetts.
