**An Order** to authorize the Mayor to accept and expend a grant in the amount of \$15,000 from the Massachusetts Interlocal Insurance Association (MIIA) Wellness Grant program to be used by the Amesbury Police Department.

**Summary:** These grant funds will be used by the Amesbury Police Department to employ SIGMA Tactical Wellness which will conduct voluntary comprehensive cardiovascular screenings for 20 members of the Amesbury Police Department. Sigma has pioneered a new system of cardio-metabolic screening which has been proven to detect cardiovascular disease more effectively than standard screening modalities. The cost is \$850 per person, totaling \$17,000 for 20 members, and these grant funds will supplement the cost. This is a reimbursable program, and funds must be spent by June 30, 2025.

**Be it Ordered by the City Council of the City of Amesbury assembled, and by the authority of the same as follows:**

That the City of Amesbury authorizes the Mayor to accept and expend a grant in the amount of \$15,000 from the Massachusetts Interlocal Insurance Association (MIIA) Wellness Grant program to be used by the Amesbury Police Department.
