**An Order** to authorize inter-departmental transfers of general fund appropriations in accordance with MGL c.44 Section 33B.

**Summary:** The City Council may, by majority vote, on recommendation of the Mayor, transfer within the last 2 months of any fiscal year, or during the first 15 days of the new fiscal year, to apply to the previous fiscal year, any amount appropriated, other than for the use of a municipal light department or a school department, to any other appropriation.
