An Ordinance to amend the City of Amesbury Traffic and Parking Regulations ARTICLE 1 – DEFINITIONS with the names of the eight parking lots owned and maintained by the City of Amesbury.

Summary: This ordinance will update the traffic and Parking Regulations adopted in Bill No. 2015-077 and subsequently amended in Bill No. 2015-081, Bill No. 2019-074, Bill No. 2022-059, Bill No. 2022-181, Bill No. 2023-100, Bill No. 2023-101, Bill No. 2024-140, Bill No. 2024-141, Bill No. 2024-142, Bill No. 2024-143 and Bill No. 2024-148 to amend the Amesbury Municipal Code to revise ARTICLE 1 – DEFINITIONS to include the names of the eight parking lots owned and maintained by the City of Amesbury. The City of Amesbury has recently gone through a reorganization of its municipal parking lots. These include the Upper Millyard Parking Lot, Lower Millyard Parking Lot, Secured Police Lot, School Street Parking Lot, Friend Street Parking Lot, Lake Gardner Parking Lot, Washington Landing Parking Lot and new City Hall Parking Lot at 5 Market St. All these lots have specific geographic locations that should be defined in the City of Amesbury Traffic and Parking Regulations.

Be it Ordained by the City Council of the City of Amesbury assembled, and by the authority of the same as follows:

1. That the City of Amesbury amend the City of Amesbury Traffic and Parking Regulations ARTICLE 1 – DEFINITIONS to include the following municipal parking lots identified below by assessor map, parcel number and street address:

a. Upper Millyard Parking Lot – Shall include all parking within the following city owned parcels:

- i. 53-275, 11 Friend Street #RR
- ii. 53-253, 25 Friend Street
- iii. 53-268, 27 Friend Street
- iv. 53-258, 7 Hamilton Court
- v. 52-191, Hamilton Court
- vi. All Parking, not listed above, off of Hamilton Court

b. Lower Millyard Parking Lot – Shall include all parking within the following city owned parcels:

- i. 53-135, Water Street
- ii. 53-109, 10 Water Street

c. Secured Police Parking Lot

- i. 52-195a, 64 Friend Street
- ii. 52-196, 17 School Street

d. School Street Parking Lot (Between Library and FD)

- i. 52-199, 13 School Street

e. Friend Street Parking Lot – Shall include all parking within the following city owned parcels:

- i. 52-193, 54 Friend Street

f. Lake Gardner Parking Lot – Shall include all parking within the following city owned parcels:

- i. 39-2, 79 High Street

g. Washington Landing Parking Lot – Shall include all parking within the following city owned parcels:

- i. 88-2, 18 Merrimac Street

h. City Hall Parking Lot – Shall include all parking within the following city owned parcels:

- i. 53-30, 5 Market Street

2. In accordance with the City Charter, this Ordinance shall become effective at the expiration of 15 days after the date of adoption.
