To the City Council of Amesbury, Massachusetts

Respectfully represents the Massachusetts Electric Company d/b/a NATIONAL GRID of North Andover, Massachusetts, that it desires to construct a line of underground electric conduits, including the necessary sustaining and protecting fixtures, under and across the public way or ways hereinafter named.

Wherefore it prays that after due notice and hearing as provided by law, it be granted permission to excavate the public highways and to run and maintain underground electric conduits, together with such sustaining and protecting fixtures as it may find necessary for the transmission of electricity, said underground conduits to be located substantially in accordance with the plan filed herewith marked – Elm Street - Amesbury, Massachusetts.







Amesbury Public Works has reviewed the proposed Pole Installation requested by National Grid and Verizon for 284 Elm Street in Amesbury on the Petition Plan WR# 30884966 dated March 20, 2025 and received by the City on May 14, 2025.

Public Works has no significant concerns with the installation of a new pole 80-50. National Grid and Verizon confirm that the proposed installation does not conflict with other utilities within the edge of the City right of way prior to installation.

Public Work's review was completed to address the City's concerns of possible underground utility conflicts. This review was not intended to provide any indication that the property owners abutting the proposed pole location have no concerns with the pole.

Prior to installation or relocation of any utility pole, DIGSAFE, the City of Amesbury Department of Public Works, and the City Water and Sewer Departments shall be informed of the proposed activities.
